## Informed Consent Waiver and Release of Liability

**Assumption of Risks:** Physical activity carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The Menomonie High School Field House provides for activities such as weight lifting, running, swimming and diving, aerobic activities, classes, and other sporting activities. These activities involve strenuous exertions of strength using various muscle groups, quick movements using speed and change of direction, and sustained physical activity that places stress on the cardiovascular system. The specific risks vary from one activity to another, but the risks range from minor injuries such as scratches, bruises, and sprains; major injuries such as broken or fractured bones, eye injuries or loss of sight, joint or back injuries, heart attacks, and concussions; and catastrophic injuries including paralysis and death.

I understand and am aware that strength, feasibility, and aerobic exercise, including the use of equipment, are potentially hazardous activities. I also understand that fitness activities involve a risk of injury and even death. I am voluntarily participating in these activities and using equipment and machinery with knowledge of the dangers involved. I hereby agree to expressly assume and accept any and all risks of injury or death.

**Release of Liability:** In consideration of gaining membership or being allowed to participate in the activities and programs of the Menomonie High School Field House and to use its facilities, equipment, and machinery in addition to the payment of any fee or charge and to waive, release and forever discharge Menomonie High School Field House and its officers, agents, employees, representatives, executors, and all others from any and all responsibilities or liability for injuries or damages resulting from my participation in any activities or my use of equipment or machinery in the facilities mentioned above or arising out of my participation in any activities as said facility. I do also hereby release all of those mentioned and any others acting upon their behalf from any responsibility or liability for any injury or damage to myself, including those caused by the negligent act or omission of any of those mentioned or others acting on their behalf or in any way arising out of or connected with my participation in any activities or the use of any equipment.
